Subject: AIEEE-2012-- Request for correcting controversial words “vice versa” & “will not be considered for admission” in “AIEEE 2012 Information Bulletin” of CBSE & keep date of issue of OBC (NCL) certificate as 01.01.2012 in Counseling Brochure of CCB-2012.

Respected Sir,

The CBSE is conducting All India Engineering Entrance Examination, AIEEE-2012. In “[AIEEE 2012 Information Bulletin](#)”, following two controversial points are creating confusion within SC, ST, OBCs of country.

(1) Controversy No.-1 [\(at page-9 of “AIEEE 2012 Information Bulletin”\)](#)

Clause 14.4:- SC, ST, OBC and PWD candidates will be required to produce original certificate issued by the competent authority at the time of counseling, failing which they will not be considered for admission.

(Controversy:- The word “failing which they will not be considered for admission” is incorrect whereas “failing which they will not be considered for admission in respective category” is correct because SC,ST,OBC candidates are considered for admission in “General” seats on the basis of their merit at any time.)

(2) Controversy No.-2 [\(at page-10 of “AIEEE 2012 Information Bulletin”\)](#)

IMPORTANT INFORMATION

1. No request for change of category from General to SC/ST,OBC and PWD

or vice versa will be entertained on the ground of issuance of such certificate after submission of Confirmation Page.

(Controversy:- The word “vice versa” is incorrect & creating confusion as candidates belonging to SC,ST,OBC category are considered for admission in “General” seats on the basis of their merit at any time. OBCs also can't predict their creamy or non creamy layer status as on 31.03.2012 today in advance.)

(2) Controversy No.-3 [\(Example-CCB\(AIEEE\)-2011- Format of OBC certificate\)](#)

Considering the [prescribed format of OBC certificate](#) available in last [CCB \(AIEEE\) 2011 Information Brochure](#) the date of issue of OBC certificate for AIEEE-2012 will be kept “on or after 01.04.2012”. Whereas, Indian Institute of Technology (IIT) which also comes under your same HRD Ministry asks to submit the OBC (NCL) certificates issued on or after 01.01.2012 for IIT JEE 2012. Getting OBC category certificates twice from authority is tedious. The OBC certificate once taken for IIT 2012 can be considered for AIEEE 2012 counseling.

Therefore it is requested to kindly:

- (1) substitute the words “failing which they will not be considered for admission in respective category” in place of “failing which they will not be considered for admission” in clause 14.4 at page 9 of “AIEEE 2012 Information Bulletin” as quoted by IIT JEE 2012 also.**
- (2) remove or delete the word “vice versa” from “IMPORTANT INFORMATION” (1) at Page 10 of “AIEEE 2012 Information Bulletin”**
- (3) keep the Date of issue of OBC certificate as “on or after 01.01.2012” in forthcoming CCB (AIEEE) 2012 Counseling Brochure & date of determination of creamy layer status/income should be kept as 31.03.2011 as given by IIT JEE 2012 also.**
